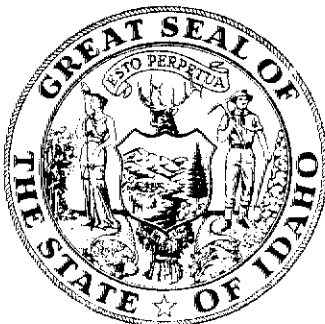

## KNOW ALL MEN BY THESE PRESENTS:

*That the undersigned, being natural persons of legal age and acting as incorporators of a corporation, under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:*

### FIRST:

*The name of the Corporation is IDAHO DRIVERS ASSOCIATION, INC.*

### SECOND:

*The period of its duration is perpetual.*

### THIRD:

*The purpose or purposes for which the corporation is organized are:*

*Transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.*

### FOURTH:

*The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND (10,000) SHARES with a no par value per share. There shall be one class of shares, all of which shall be common shares.*

### FIFTH:




