The undersigned, in order to form a Non-Profit Corporation under the provisions of Title 30, Chapter 3, Idaho Code, submits the following articles of incorporation to the Secretary of State.

Article 1: The name of the corporation shall be:

**Mountain States Advanced Tactics and
Training (MATT) Inc.**

Article 2: The purpose for which the corporation is organized is:

1. To teach at risk youth the basic tenants of martial arts which are: Self Confidence., Strength, Respect, and Dedicating oneself to reaching goals.
2. To provide an alternative activity to at risk youth in place of street gangs, drugs, and violence.
3. To promote positive leadership and role models for the youth of the community.
4. To reduce juvenile repeat offenders in the community by providing a positive environment to learn and lead.
5. To assist law enforcement with furthering their self defense tactics beyond the police academy.
6. To provide law enforcement with an opportunity to employ, practice, and improve previously taught self defense tactics by incorporating our advanced system of combined martial arts, military and law enforcement techniques.
7. To promote a safe environment for training and conditioning of all students, and faculty, free of outside influences the academy does not have control over.
8. To improve all aspects of law enforcement tactics and training.



Article 7: The Corporation does not have voting members


Article 8: Upon dissolution the assets shall be distributed:
