

ARTICLES OF INCORPORATION.

WHEREAS, Daniel T. Carroll, John C. Hodge, Charles Laskerman, of Horseshoe Bend, Boise County, Idaho, John Kinkaid and Louis M. Pritchard, of Boise, Ada County, Idaho, have associated themselves together for the purpose of incorporation under the general incorporation laws of the State of Idaho, do therefore make, sign and acknowledge these Articles in duplicate in writing which when filed shall constitute the Articles of Incorporation of "The Shafer Creek Gold Mining Company, Limited".

Article 1" :- The name of said company shall be "The Shafer Creek Gold Mining Company, Limited".

Article 2" :- The objects for which said company is created are to discover, locate, acquire, hold, work and operate mines of gold, silver, cinnabar and copper bearing ores and all ores containing the precious metals in any of the United States but especially in the State of Idaho, to mill and treat the same and to do any and all things incident to the general business of mining and reduction of ores.

Article 3" :- The term of the existence of said company shall be fifty years.

Article 4" :- The capital stock of said company shall be One Hundred Thousand Dollars divided into Ten Thousand shares of the par value of ten dollars each.

Article 5" :- The number of directors of said company shall be five and the names and the post-office address of those who shall manage the affairs of the company for the first year of its existence are,

Article 6th :- The principal business office of said company shall be kept at the City of Boise, Ada County, Idaho, where its principal business will be transacted.
