



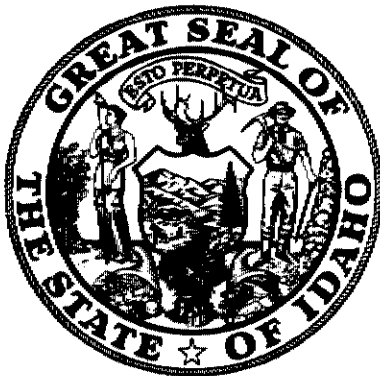
**CERTIFICATE OF INCORPORATION

I, the undersigned natural person of the age of twenty-one (21) years or more, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE ONE - NAME

The name of this corporation is SDF INC.

ARTICLE TWO - DURATION

The duration of this corporation is perpetual.

ARTICLE THREE - PURPOSES

The purpose for which this corporation is organized shall be the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
