That I, the undersigned, being natural citizen of the United States and of full age and majority, have this day and do hereby voluntarily associate myself together for the purpose of forming a corporation under the laws of the State of Idaho, and I do hereby certify:

ARTICLE I.

The purposes and objects for which this corporation are formed are:


