

**ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION OF
SOUTH EAST BOISE, IDAHO, CONGREGATIONS
OF JEHOVAH'S WITNESSES, INC.**

Pursuant to the provisions of Section 30-326 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

The name of the corporation is SOUTH EAST BOISE, IDAHO, CONGREGATIONS OF JEHOVAH'S WITNESSES, INC. ("Corporation").

ARTICLE II

The following amendments to the Articles of Incorporation were adopted by the Membership of the Corporation in the manner prescribed by the Idaho Nonprofit Corporation Act:

RESOLVED that **ARTICLE I** of the Articles of Incorporation of the Corporation be amended to read in full as follows:

ARTICLE I

The name of the corporation is BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES, INC.

RESOLVED that **ARTICLE IV** of the Articles of Incorporation of

the Corporation be amended to read in full as follows:

ARTICLE IV

The objects for which the Corporation is formed are to further the preaching and teaching of the Gospel of God's Kingdom; to proclaim the overall Supremacy of Almighty God, Jehovah; to conduct schools and classes for teaching and to teach the Bible and Bible Truths; to buy, sell, or give away and otherwise distribute Bibles and other literature concerning and containing information and comment explaining Bible Truths and prophesy concerning the establishment of Jehovah's Kingdom under Jesus Christ; to hold title to and establish a Kingdom Hall as a meeting place and place of worship for the members of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES.

RESOLVED that ARTICLE VI of the Articles of Incorporation of the Corporation be amended to read in full as follows:

ARTICLE VI

Any person who is duly recognized as a member of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES by the WATCHTOWER BIBLE AND TRACT SOCIETY, Brooklyn, New York, shall be a Member of the Corporation, and any person who shall subsequently become duly recognized as a member of the BOISE SOUTH CONGREGATION OF JEHOVAH'S WITNESSES by the WATCHTOWER BIBLE AND TRACT SOCIETY, Brooklyn, New York, shall likewise become a Member of the Corporation.

ARTICLE III

The date of the meeting at which the amendments were adopted was Oct 30, 1988. The number of Members of the Corporation present at the meeting was 181, which constitutes a quorum.

ARTICLE IV

The number of Members voting for the amendments was 181 and

the number of Members voting against the amendments was zero (0). The amendments were adopted by a majority of the votes which members present at the meeting in person or by proxy were entitled to cast.
