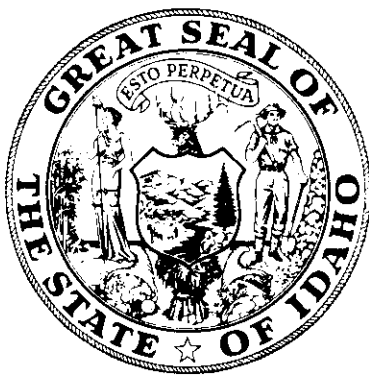

All the property and assets of the corporation has been acquired by Dave and Deana Hockman as set forth in Article IV above and otherwise in accordance with the Articles of Incorporation.


VI


