# ARTICLES OF INCORPORATION RECEIVED SEC. OF STATE

We, the undersigned persons, acting as the incorporators of a private, non-profit corporation under the provisions of the Idaho Nonprofit Corporation Act (Title 30, Chapter 3, Idaho Code), adopt the following Articles of Incorporation.

### Article I

#### <u>Name</u>

The name of the corporation is: Teton Valley Arts and Humanities Association, Incorporated.

### Article II

## Non-Profit Status

The corporation is a private non-profit corporation.

#### Article III

#### Duration

The period of duration of this corporation shall be perpetual.

#### Article IV

#### Purposes

This corporation is organized for the following charitable and educational purposes:

- (a) To promote the arts and humanities in Teton Valley by promoting historical, artistic and educational events.
- (b) To develop ways and means of providing funds for the above purpose through membership, contributions, and fundraising events.
- (c) To engage in any activity that lawfully may be conducted by a non-profit corporation organized under Title 30, Chapter 3, of the Idaho Code.

## Article V <u>Exclusive Charitable Purpose</u>

This organization is organized exclusively for charitable

purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

#### Article VI

## Management. Directors

The corporation shall be managed by a board of directors, who shall be a minimum of three and a maximum of seven in number. They shall include a president, a vice-president, a secretary, and a treasurer. The initial number of directors shall be three.

#### Article VII

## Registered Office - Agent

The address of the initial registered office of the corporation shall be 528 N. Highway 33, Tetonia, Idaho 83452. The name of the initial registered agent at such address shall be Gretchen Notzold.

## Article VIII

#### **Dissolution**

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code."
