ARTICLES OF MERGER OF DOMESTIC AND FOREIGN CORPORATION INTO SCI, Inc., a Washington corporation.

Pursuant to the provisions of the Washington Corporations Act and the Idaho Corporations Act, the undersigned domestic and foreign corporations adopt the following Articles of Merger for the purpose of merging them into a single, surviving, corporation.

FIRST: The names of the undersigned corporations and the States under the laws of which they are respectively organized are:
