ARTICLES OF INCORPORATION

- OF -

" SPCKANE AND EASTERN TRUST COMPANY"

KYOW ALL MEN BY THESE PRESENTS:

That we, John P. M. Richards, James N. Glover, Fred D. Chamberlin, Horace L. Cutter, Arthur A. Newbery, Jules L. Prickett, Frank Rockwood Moore, citizens of the United States and residents of the State of Washington, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Washington, and we do hereby certify and conclude upon the following articles of incorporation.

ARTICLE (1)

That the name of this corporation is and shallbe "Spokane and Eastern Trust Company".

ARTICLE (2)

That the objects and purposes for which this corporation is formed are as follows, to-wit:

To act as the Fiscal or Transfer Agent of any State, (A) Municipality, Body-politic or Corporation; and in such capacity to receive and disburse money, transfer, register and countersign certificates of stock, bonds or other evidences of indebtedness. To receive deposits of trust moneys, securities and other personal property from any person or corporation. To act as Trustee under any mortgage or bond issued by any Municipality, Body-politic or Corporation and accept and execute any other municipal or corporate trust not inconsistent with the laws of this State. To take, accept and execute any and all such legal trusts, duties and powers in regard to holding, managing and disposing of any estate or property, real or personal and the rents, issues and profits thereof or the sale thereof as may be granted or confided to it, by any Court of Record or by any person, Corporation, Municipality , or other authority, as Agent, Executor, Administrator, Guardian, Receiver, Trustee or otherwise where the same is not prohibited by the laws of this State. To act as surety upon bonds and undertakings given in legal proceedings or otherwise; to guarantee the honesty and fidelity of clerks, employees, officers and other persons.

(B) To loan money and take as security therefor, all kinds

of real estate, chattels, bonds, notes, stocks, warrants and other evidence of debt, both for itself and in its corporate name and as Agent of Trustee for other Corporations and persons.

(C) To take, hold, purchase, sell, assign, pledge, hypothecat

To take, hold, purchase, sell, assign, pledge, hypothecate release and otherwise acquire, dispose of and deal in mortgages and other liens on real estate and personal property, and bills, bonds, notes, stocks and warrants of all kinds and other negotiable papar and evidences of debt both for itself and in its corporate name

and as Agent or Trustee for other Corporations and persons.

(D) To buy, sell, mortgage, convey, contract for, lease, improve and in all other ways deal in lands, tenements and hereditaments both for itself and in its corporate name and as Agent for

other Corporations and persons.

(E) , To erect, construct, repair, improve, hold, sell, lease, rent, mortgage and deal in dwellings, stores and buildings of all kinds both for itself and in its corporate name and as Agent or

Trustee for other Corporations and persons.
(F) To execute, sell and tranfer bonds, debentures, notes and other evidences of debt of this Epsporation, for money or property received, or labor done, unsecured or secured by mortgage

note or notes, and first mortgage or mortgages on real estate or trust deeds of real estate.

(G) To carry on the business of banking by discounting and negotiating promissory notes, drafts, bills of exchange and all other evidences of debt, by receiving deposits on time or otherwise, buying and selling exchange, coin and bullion, and to do and perform any and all other acts and things pertaining to a general

(H) To do every act and thing requisite and proper in conducting and carrying on a general trust, investment and agency business. To borrow money for any and all of the purposes herein stated, upon its secured or unsecured evidences of debt. To do and perform any and all of the acts and things above mentioned and carry on the business aforesaid in the State of Washington and in any other State and Territory of the United States.

ARTICLE (3)

That the amount of capital stock of this Corporation shall Hundred Thousand Dollars (\$100,000) and shall be divided into One Thousand (1,000) shares of the par value of One Hundred Dollars (\$100) each.

ARTICLE (4)

That the term for which this Corporation is to exist is Fifty (50) years from and after the date of its incorporation.

ARTICLE (5)

That the principal place of business of this Corporation shall be the City of Spokane Falls, Spokane County, State of Wash-

ARTICLE (6)

That the business of this Corporation shall be managed and conducted by a Board of Seven (7) Trustees, all of whom shall be stock-holders of the Company, each owning and holding at least Ten (10) shares of stock thereof and the majority of them shall be citizens of the United States and Pesidents of the State of Washcitizens of the United States and Pesidents of the State of Washligton.
