

ARTICLES OF INCORPORATION.

OF

THE KETCHUM LIVESTOCK ASSOCIATION.

We, the undersigned bona fide residents of the State of Idaho desire to form a corporation under the laws of the State of Idaho, do hereby mutually agree as follows:

1. The name of this Corporation shall be the
"KETCHUM LIVESTOCK ASSOCIATION."
2. This corporation is formed for the purpose of owning, renting and holding sufficient land for the proper care and handling of sheep preparatory to shipping them to market. Providing cutting out corrals, branding chutes, watering places and all other things necessary or incidentals thereto.
3. The place where the principal business is to be transacted, is Hailey, Idaho.
4. The term for which this corporation is to exist, shall be fifty (50) years.
5. There shall be five Directors, who shall hold their offices for one year and until their successors shall have been elected and qualified.
6. Those holding for the first year shall be
Earlow Ferguson, President and Director,
James Laidlaw, Vice President and Director,
S.P. Newman, Secretary- Treasurer,
T.C. Bacon, Director,
Ben. Darrah, Director,
Lee Vader, Director.

The capital stock of this corporation shall be Ten Thousand (10,000) Dollars, divided into ten thousand shares of the par value of One Dollar (\$1.00) each.
