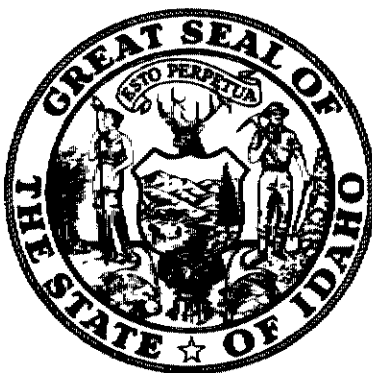

ARTICLE I

The name of the corporation shall be The A.R.K.-Arms Reaching Kids Incorporated.

ARTICLE II

This is a nonprofit corporation and is organized exclusively for religious, charitable, literary, and educational purposes within the meaning of Section 501 (C) (3) of the Internal Revenue Code.

ARTICLE III

The duration of said corporation shall be perpetual.

ARTICLE IV

Specifically, the corporation is organized to provide for the Physical, Mental, and Spiritual needs of the homeless children, by establishing a Shelter Home, raising charitable funds for the purposes of providing for debts incurred by the corporation, as well as promoting the religious education of all who willingly receive it.

Notwithstanding any other provisions of there articles, the corporation shall not carry on any other activities not permitted to be carried on by any organization exempt from Federal Income Tax under Section 501 (C) (3) of the Internal Revenue Code.

ARTICLE V

This corporation will have members.

ARTICLE VI

All members of said corporation will sit on the Board of Directors.

ARTICLE VII

Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to the Lighthouse Ministry of Salt Lake City, Utah, which has established its tax-exempt status under Section 501 (C) (3) of the Internal Revenue Code.
