
#### OWYHEE RESOURCE COMPANY

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of legal age and a citizen of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

I.

#### Name

The name of the corporation shall be Owyhee Resource Company.

II.

#### Registered Office

The period of existence and duration of the corporation shall be perpetual.

#### Director Conflicts Of Interest

other transaction contract or between corporation and any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the corporation, and no act of the corporation, shall be in any way affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in, or are directors or of such other corporation; any individually, or any firm of which such director may be a member, may be a party to, or may be pecuniarily or otherwise interested in. any contract or transaction of corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors; and the director of the corporation who is also so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation which shall authorize such contract or transaction, with like force and effect as if he were not such directors or officer of such other corporation, or not so interested.
