ARTICLES OF INCORPORATION

OF

WESTECH CORPORATION

1.

The name of the corporation is Westech Corporation.

2.

The corporation shall have perpetual duration.

3.

The corporation is organized under the Georgia Business Corporation Code for profit and is organized for the following purposes: to engage in the business of general mechanical contracting; to construct, erect, install and service all types of mechanical systems in all types of buildings or other structures; to buy and sell at wholesale or retail all types of mechanical equipment, parts, accessories and related products; to buy, sell, own, mortgage, lease, exchange, operate and manage any type of property, real or personal; to buy, own, sell and deal in generally the notes, bonds, stock and other evidence of indebtedness of and ownership in corporations; to borrow money on notes, or on mortgages or security deeds secured by real property, or on personal property, and to lend money in such manner and upon such terms and conditions and with such security as the officers of the corporation may deem desirable; and said corporation is further organized for any other lawful purpose as authorized by the Georgia Business Corporation Code.

The corporation has authority to issue not more than 100,000 shares of common stock at \$10.00 par value.

5.

The corporation will not commence business until it shall have received not less than \$10,000 in payment for the issuance of shares of stock.


