- 1. The name of the corporation shall be GEM STATE DEVELOPMENTAL CENTER, Incorporated as per yeary Foculer
- 2. GEM STATE DEVELOPMENTAL CENTER, is to be established as a for-profit corporation.
- 3. The duration of the corporation shall be perpetual.
- 4. The purpose of the corporation shall be to provide out-patient clinical services to mentally disabled persons.
- 5. The corporation shall be authorized to issue fifty (50) shares of common stock, one vote per share, one dollar per share, for a total capitalization of \$50.00.
- 6. The corporation shall have a president, vice president and secretary-treasurer. The president will serve as a director and his responsibility and duty shall be to manage the affairs of the corporation consistent with this act.
