ARTICLES OF INCORPORATION

OF

The undersigned, acting as the Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such Corporation:

I.

The name of the Corporation is SUN VALLEY HOT TUB SERVICE, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the Corporation is organized are transaction of any and all lawful business for which Corporations may be incorporated under the Idaho Business Corporation Act.

IV.
