

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF PLANTATION ROUND TABLE PIZZA, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: The name of the corporation is Plantation Round Table Pizza, Inc.

SECOND: The following amendment to the Articles of Incorporation were adopted by the shareholders of the corporation on March 28, 1986, in the manner prescribed by the Idaho Business Corporation Act:

That henceforth the name of the corporation is Spud, Jr., Inc.

THIRD: The number of shares of the corporation outstanding at the time of the adoption was 250,000; and the number of shares entitled to vote thereon was 250,000.

FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:


