ARTICLES OF INCORPORATION

of

KAYLER LODGE #94 A. F. & A. M., INC.

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, all of whom are natural persons of legal age and citizens of the United States of America and members of Kayler Lodge #94 A. F. & A. M., where pecuniary gain or profit are not the object, and having been duly elected Directors of said Kayler Lodge #94 A. F. & A. M. and for the purpose of forming a benevolent, charitable and fraternal organization under the provisions of Chapter 11, Title 30, Idaho Code, do hereby associate ourselves and other members of said organization under the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be KAYLER LODGE #94 A. F. & A. M., INC.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The location and post office address of the registered office of this corporation and place where the principal business is being transacted is 883 Blue Lakes Boulevard North, Twin Falls, Idaho 83301.

ARTICLE IV

Pecuniary profit or gain are not the object of this corporation, and there shall be no capital stock.

ARTICLE V

The terms and qualifications for admission to membership in this corporation and the rights and privileges of members shall be determined by the By-Laws of the corporation. Members of the corporation shall consist of all members of Kayler Lodge #94 A. F. & A. M.

## ARTICLE VI

The purposes for which this corporation is formed are as follows:

1. For fraternal, charitable and benevolent purposes and to cultivate social intercourse among its members and improve the moral and social condition of its membership.
2. To purchase, hold, lease, possess and enjoy real or personal property necessary or incidental to or in connection with the purposes of the corporation and to sell, lease, mortgage or otherwise hypothecate such property and to borrow money for the accomplishment of any of the purposes of the corporation.
3. The corporation shall have in addition all further rights, powers and privileges granted under the laws of the State of Idaho.

## ARTICLE VII

The number of Directors of the corporation shall be five. The names and residences of those who are elected for the first year and until election and qualification of their successors are as follows:

No person shall be a Director of the corporation unless he is a member thereof. The Board of Directors shall select a President, two Vice-Presidents, A Secretary and a Treasurer.

#### ARTICLE VIII

The names of all incorporators of this corporation and post office addresses of each are as listed and set forth in Article VII hereof.

#### ARTICLE IX

An election of Directors of the corporation was held in accordance with the laws of the State of Idaho at Twin Falls, Twin Falls County, Idaho, on the 6<sup>th</sup> day of January, 1977, at its regular meeting place located at 883 Blue Lakes Boulevard North, Twin Falls, Idaho, and a majority of the members of Kayler Lodge #94 A. F. & A. M. who were present at such meeting voted at such election of Directors and the persons set forth and named in Article VII of these Articles of Incorporation were elected Directors of this corporation; that Glen Cannon and Walter Slaughter were the Chairman and Secretary, respectively, of said meeting and conducted said election; that due and legal notice of the time and place of holding said meeting and election of Directors was given by publication for at least two weeks prior to said election in the Times-News newspaper, Twin Falls, Idaho, and published therein on December 16 and 23, 1976; that the notice of meeting which was published as aforesaid is in words and figures as follows:
