

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:---

First:- That the name of said corporation is the American Ditch Association.

Second:- That the purposes for which it is formed are to own water and water rights to be taken from Boise River in Canyon County, Idaho, and to own and operate ditches and canals for the distribution of the same, and particularly to form a farmer's co-operative association for the purpose of purchasing and owning for the use of the members thereof, the water and water rights ditches, canals and laterals now owned and operated by the American Ditch Company in Canyon County, Idaho and to succeed to all the right, title and interest of said Company in and to the property now owned and operated by it in said Canyon County.

Third:- That the place where its principal business is to be transacted shall be Center Point school-house, County of Canyon, State of Idaho.

Fourth:- That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth:- That the number of its Directors shall be five(5) and that the names and residences of those who are appointed for the first year are:-
