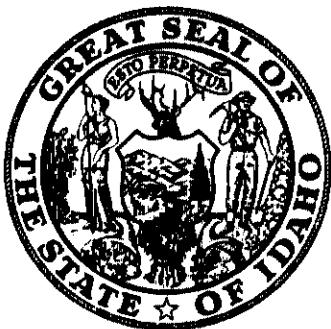
CERTIFICATE OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS: that we as the undersigned being of legal age, citizens and residents of the United States, for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho relating to private corporations, have this day voluntarily associated ourselves together and hereby agree as follow:

ARTICLE I

Name of the corporation shall be W & J Farming, Inc.

ARTICLE II

This corporation shall have perpetual existence, unless the same is sooner dissolved or disincorporated pursuant to law.

ARTICLE III

Said corporation is organized for the purpose or purposes of conducting any and all lawful business for which corporations may be incorporated in the State of Idaho.

ARTICLE IV

Said corporation shall have authority to issue Ten Thousand (10,000) shares of common stock at a par value of Ten Dollars (\$10.00) per share.

ARTICLE V

Said corporation is organized at, and the place of its




