ARTICLES OF INCORPORATION

SECRETARY OF STATE STATE OF IDAHO

Corporate Name

The name of the corporation shall be "Dondy's Incorporated."

Duration

The period of duration is perpetual.

Purpose

The purpose for which the corporation is organized includes the transaction of any and all lawful business for which corporations may be incorporated under this act.

Shares

The aggregate number of shares which the corporation shall have authority to issue is 100.

Shares are to consist of one class of no par value shares with voting rights of one vote per share.
