



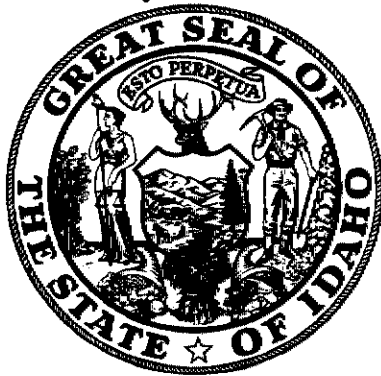
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
WESTERN BALLISTICS CORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

I.

The name of the corporation shall be WESTERN BALLISTICS CORPORATION.

II.

The nature, objects and purposes for which this corporation is formed shall be:

(a) To engage in the general construction business, including drilling rock, dynamite blasting, excavation, to operate a contracting business; to purchase, own, hold, and sell real property, improved and unimproved, or any interest therein or easement thereon; to purchase lands and subdivide same into subdivisions or lots; to loan money upon real property and to accept secured and unsecured notes as collateral for same; to execute notes, deeds of trust, mortgages, chattel mortgages; to enter into leases as landlord or tenant; to perform or do any act customarily performed or done by a contractor and builder, speculative builder, subdivider, or real property development; to reinvest in and hold for investment any and all real property, shares of stock, bonds, government, private or corporate; to exchange and enter into agreements of exchange of one parcel of real property for another parcel of real property.

(b) To carry on the primary business in which the corporation intends to initially engage; to employ engineers, architects, builders, and contractors for the purpose of or in connection with the construction, erecting, altering, repairing, improving, or doing any other work in connection with any houses, industrial buildings, plants, workshops, factories, schools, roads, quarries, or other buildings, works, or structures of every kind and description wheresoever; and to manufacture, buy, sell, purchase, distribute and deal in any and all kinds of building materials, building supplies, or products of any and every kind or character, and to do any and all things necessary and proper to effect such purpose.

(c) To buy, sell, and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same, to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of other corporations.

(d) To acquire by purchase, subscription or otherwise, and to hold and hypothecate and to dispose of stocks, bonds, or any other obligation of all kinds, and to sell, trade in and exchange the same, and all classes of stocks, bonds, notes, bills of sale and other securities.

(e) To buy, hold, purchase, contract for, own, sell, mortgage, lease, or exchange real or personal property of all kinds.

(f) To carry into effect the object and purposes aforesaid, this corporation is authorized to do all and singular the things necessary and convenient to carry out the general purposes for which it is organized.

(g) To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefore, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of the corporation may be pledged, mortgaged or hypothecated.

(h) To carry on any other business, or do anything in connection with objects and purposes above mentioned that may be necessary and proper to accomplish successfully or promote the said objects and purposes, the foregoing clauses, by reason of the specific enumeration of powers, shall not be held to restrict the power of the corporation to do any of the things within due of its general powers.

III.

The duration of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of this corporation is and shall be 7827 West Mossy Cup Street, Boise, Idaho 83709. *THE REGISTERED AGENT SHALL BE, LARRY D. GRAVES*

V.

The total authorized number of shares which may be issued by this corporation is ten thousand shares (10,000) of common stock, non-assessable, with a par value of One Dollar (\$1.00) per share, for a total capitalization of \$10,000.00.

VI.



All shares of this corporation are the same class with equal rights and voting power and without preference of priority of any share over any other share.

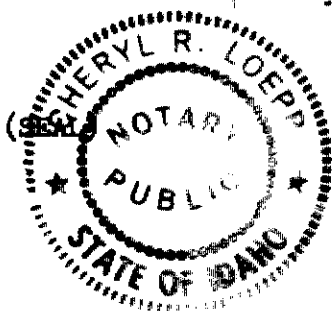
