ARTICLES OF INCORPORATION ED

KNOW ALL MEN BY THESE PRESENTS, that I, the undersigned incorporator being of the age of eighteen years or more, desiring to organize a non-profit corporation under the laws of the State of Idaho, do hereby make, sign and verify these Articles of incorporation.

ARTICLE 1.

The name of the corporation is UNIT THREE WATER **

ASSOCIATION, INC., and shall be referred to hereinafter as the "Corporation".

ARTICLE II.

This Corporation is a non-profit corporation, incorporated under the provisions of Idaho Code \$ 30-301, et seq. No percuniary profit to the members of the corporation is contemplated.

ARTICLE III.

The Corporation's duration shall be perpetual.

ARTICLE IV.

The Corporation is organized for the following purposes:

(a) To acquire, by purchase, lease, or other lawful means, a supply of domestic water, and the pumps, motors, pipe, meters and all other necessary machinery and equipment necessary and sufficient to furnish domestic water to the

owners and residents of real property located in Jerome

County, Idaho, and more particularly described as Big Little

Ranches Unit Three, according to the official plat thereof of
record with the Jerome County, Idaho Recorder, being located
in Section 16, Township 9 South, Range 17 East of the Boise

Meridian, Jerome County, Idaho;

- (b) To provide for the assessment of members of the Corporation for the use of the water from the system and the cost of operating, repairing and maintaining the water delivery system;
- (c) To exercise all powers and privileges and perform all the duties and obligations set forth in that certain

 Declaration of Restrictive Covenants of record with the Jerome County, Idaho Recorder which restrictive covenants are applicable to any portion of the real property described in paragraph (a) above.
- (d) To fix, levy, collect and enforce payment by any lawful means, all charges or assessments pursuant to the terms of the Declaration of Restrictive Covenants; to pay all expenses in connection therewith and all other expenses incidental to the conduct of the business of the Corporation, including any taxes or assessments levied against the Corporation;
- (e) To participate in mergers, consolidations or other working arrangements with other non-profit corporations for the same purposes for which this Corporation is created;

(f) To carry out any other business activity or purpose necessary or incidental to the primary business purposes above recited, or which may be appropriate for non-profit corporations to exercise under the provisions of idaho Code § 30-301 et seq.

ARTICLE V.

The Corporation shall have members. The ownership of one lot within the boundaries of the Big Little Ranches Unit Three Subdivision shall make the owner eligible for membership.

Actual membership shall be granted by the Board of Directors of the Corporation in accordance with its duly adopted By-Laws.
