CERTIFICATÉ OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF THE COOPERATIVE SUPPLY INC.

COEUR D'ALENE, IDAHO

We, the undersigned, Sam Rodius and Arthur Hussa, respectively the President and Secretary of the Cooperative Supply Inc., P. O. Coeur d'Alene, Idaho, a cooperative association, now organized and operating under the provisions of the Cooperative Marketing Act of Idaho, as amended, hereby certify:

- 1. That on 12-20-5-7, the board of directors by a two-thirds majority vote of its members at a duly held meeting adopted a Resolution proposing to amend the Articles of Incorporation of the aforesaid association, which Resolution set forth the proposed amendment.
- 3. That at said time and place at least a two-thirds majority of the stockholders present, a quorum being present, duly adopted said proposed amendment as set forth in the Resolution and stated as follows:

RESOLVED, That Section 1 of Articles III of the Articles of Incorporation of the Cooperative Supply, Inc., P. O. Coeur d'Alene, Idaho, be amended to read as follows:

"Section 1. The amount of the authorized capital stock of this corporation shall be Five Hundred Thousand Dollars (\$500,000.00), which shall consist of Three Thousand (3,000) shares of Common Stock of the par value of Ten Dollars (\$10.00) each; Forty-three Thousand (43,000) shares of Preferred Stock of the par value of Ten Dollars (\$10.00) each; and Four Thousand (4,000) shares of Preferred Stock A of the par value of Ten Dollars (\$10.00) each."

BE IT FURTHER RESOLVED, That the President and Secretary of this association be and they hereby are, authorized and directed to make, execute and acknowledge a certificate under the corporate seal of this association and cause such certificate to be filed and recorded in the manner required by law.
