I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for perpetual existence from the date hereof, with its registered office in this State located at Weiser in the County of Washington.

1 ARTICLES OF INCORPORATION 2 OF 3 MANN CREEK BUSY BEE CLUB, INC. 4 5 KNOW ALL MEN BY THESE PRESENTS: That we, DELPHA WILLIAMSON, EDNA 6 JACKSON, LILLIAN T. JONES, VIOLA TURNIDGE and MARGARET PEDRO, each of 7 whom is a citizen of the United States of America, over the age of twenty-one 8 (21) years, and a resident of the State of Idaho, and of the Manns Creek Community in Washington County, Idaho, desiring to form a non-profit corporation under and 10 by virtue of the laws of the State of Idaho, do hereby associate ourselves to-11 gether for said purpose and execute, acknowledge, adopt and file the following 12 13 Articles of Incorporation: 14 ARTICLE I. 15 The name of this corporation shall be MANN CREEK BUSY BEE CLUB, INC.; 16 17 ARTICLE II. 18 The names and addresses of the persons so associating themselves together for 19 20 the purposes aforesaid are DELPHA WILLIAMSON, EDNA JACKSON, LILLIAN T. 21 JONES, VIOLA TURNIDGE and MARGARET PEDRO, all of whom reside and have their 22 Post Office address at Weiser, Idaho; 23

ARTICLE III.

That the general nature of the business to be transacted by this corporation and the objects and purposes for which this corporation are formed are as follows:

To acquire the necessary real and personal property; to operate a community center as a place for holding public gatherings, business meetings and social events within the area wherein its members reside, to operate as a community center for the purpose of promoting the welfare of its membership; to create an organization whose membership shall be composed of persons residing in the

Mann Creek area of Washington County, Idaho, and such other persons who may by the vote of the Board of Directors be admitted to membership, to the end and purpose that concerted action can be obtained in behalf of the promotion of enterprises or projects beneficial to its members, to provide a place for a forum where open meetings can be had for the discussion of problems concerning the welfare of its members, and to do all things necessary or convenient for the accomplishment of the above mentioned purposes.

ARTICLE IV.

The principal place of business and registered office of this corporation shall be Weiser, Idaho;

ARTICLE V.

This corporation shall have no capital stock but shall issue certificates of membership to all qualified persons who desire to become members of said organization; any person residing in the Mann Creek Community shall be eligible to membership in this corporation, and a certificate of membership shall be issued to him or her upon application and payment of the membership fee;

ARTICLE VI.

That the government and management of the business affairs of this corporation shall be vested in a Board of five (5) Directors and that DELPHA WILLIAMSON, EDNA JACKSON, LILLIAN T. JONES, VIOLA TURNIDGE and MARGARET PEDRO shall constitute the First Board of Directors of this corporation and shall hold their offices as such until their successors are elected and qualified;

ARTICLE VII.

The Directors, as well as the members, shall have power to make such prudential By-Laws as they may deem proper for the management of the corporation, not inconsistent with the General By-Laws of the corporation, and power is hereby

conferred upon the Board of Directors by a three-fifths vote of said Directors to repeal and/or amend the general By-Laws of the corporation and to adopt new general By-Laws;

ARTICLE VIII.

The time of commencement of this corporation shall be the date on which a copy of these Articles of Incorporation is filed in the office of the Secretary of State of the State of Idaho, and in the office of the County Recorder of Washington County, Idaho, and the existence of this corporation shall be perpetual.
