



- 1. He is the sole incorporator of PACIFIC WESTERN MAINTENANCE, INC., a California corporation.
- 2. He hereby adopts the following amendments of the Articles of Incorporation of said corporation:

Article I is amended to read as follows:

"The name of the corporation is STOCKMAR INDUSTRIES, INC."

3. Article IV is amended to read as follows:

"This corporation is authorized to issue only one class of shares of stock; and the total number of shares which this corporation is authorized to issue is 10,000,000."
