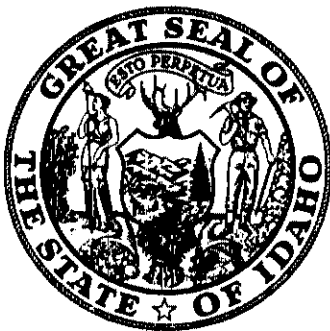
CERTIFICATE OF AMENDMENT OF


