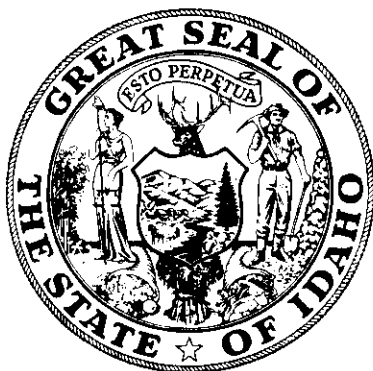

ARTICLES OF INCORPORATION  
WAHL FARMS, INC.  
SECRETARY OF  
STATE

The undersigned, each of whom is a natural person of adult age and a citizen of the United State of America, in order to organize a corporation for profit under The Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

I.

The name of the corporation is WAHL FARMS, INC.

II.

The period of its duration is perpetual.

III.

The purpose of the corporation is to engage in the business of farming and all other activities not forbidden by law.

IV.

The corporation is authorized to issue Two Hundred Fifty (250) shares of capital stock, all of one class, of par value One Thousand Dollars (\$1,000), for a total authorized capital of Two Hundred Fifty Thousand Dollars (\$250,000.00).

V.

The internal affairs of the corporation shall be governed by Bylaws adopted by two-thirds (2/3) vote of the shareholders.
