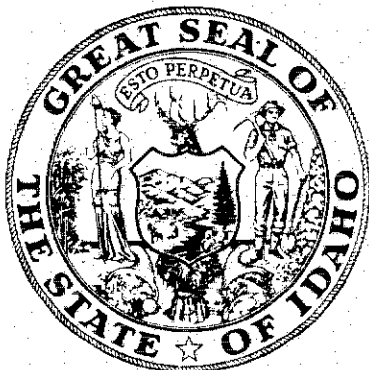

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Schabot, Peterson and Co., P.A.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on March 1st, 1984, in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation was changed to SCHABOT, SHRIVER AND CO., P.A.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1000; and the number of shares entitled to vote thereon was 1000.


FOURTH: The designation and number of outstanding shares of each class entitled to vote thereon as a class were as follows:


