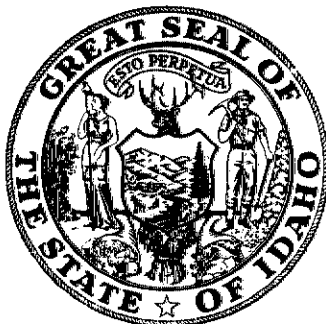

I, the undersigned acting as incorporator of a corporation under Title 3C, Chapter 1, Idaho Code (Idaho Business Corporation Act) adopts the following Articles of incorporation for such Corporation:

FIRST: The name of the Corporation is PLAN Z ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose of this corporation is the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

FOURTH: The amount of total authorized Capitol Stock of the corporation is divided into 100,000 shares of one class with no par value.

FIFTH: The preferences, qualifications, limitations, restrictions, and special or relative rights in respect to the shares are set forth in the corporation bylaws.
