

CERTIFICATE OF AMENDMENT OF ARTICLES OF INCORPORATION

I, JAS. H. YOUNG, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the

LOST RIVER ELECTRIC COOPERATIVE, INC.

a corporation organized and existing under and by virtue of the laws of the State of Idaho, filed in this office on the 21st day of November 19 57, original articles of amendment, as provided by Section 8 30-116 and 30-117, Idaho Code, amending Section 11 of Article 3; Section 8 (a) of Article 3; and amending Article 7; also changing the principal place of business to Mackay, Custer County, Idaho

and that the said articles of amendment contain the statement of facts required by law, and are recorded on Film No.

100 of Record of Domestic Corporations of the State of Idaho.

I THEREFORE FURTHER CERTIFY, That the Articles of Incorporation have been amended accordingly.

ARTICLES OF AMENDMENT of Articles of Incorporation of LOST RIVER BLECTRIC COO. RATIVE, IRC.

We, the undersigned, M. M. Wintze, and Eldred L. Braithwaite, respectively the President and Secretary of Lost River Electric Cooperative, Inc., a non-profit Domestic Corporation, do hereby certify as follows:

That at the annual meeting of the members of said non-profit corporation dely held November 13, 1951, at 3:00 P. H. of raid day pursuant to notice duly given, as required by law and which meeting duly had under consideration the proposition of amending the Articles of Incorporation of said corporation as hereinafter set forth, the following resolutions were duly adopted by said corporation, to-wit:

Resolved that Section 4 of Article 3 of the Articles of Incorporation be amended to read as follows, to-wit:

"Section 4. Each member shall, as soon as electric energy shall be available, purchase from the corporation all electric energy used on the premises specified in his application for membership, and shall pay therefor monthly at rate which shall from time to time be fixed by the board of directors; provided, however, that the board of directors may limit the amount of electric energy which the corporation shall be required to furnish to any one member. It is expressly understood that amounts paid for electric energy in excess of the cost of service are furnished by members as capital and each member shall be credited with the capital so furnished as provided in these Bylaws. Each member shall pay to the corporation such minimum amount per month regardless of the amount of electric energy consumed, as shall be fixed by the board of directors from time to time. Each member shall also pay all amounts owed by him to the corporation as and when the same shall become due and payable."

Resolved that Section 8 (a) of article 3 of the Articles of Incorporation be amended to read as follows:

"Section 8. (a) Membership in the corporation and a certificate representing the same shall not be transferable, except as hereinafter otherwise provided, and upon the death, cessation of existence, expulsion or withdrawal of a member the membership of such member shall thereupon terminate, and the certificate of membership or such member shall be surrendered forthwith to the corporation. Termination of membership in any manner shall not release the member from the debts or liabilities of such member to the corporation."

Resolved Article 7 of the Articles of Incorporation be amended to read as follows, to-wit:

"ARTICLE VII

The operations of the corporation shall be carried on in the counties of Butte and Custer, in the state of Idaho, and in such other counties in the state of Idaho, and in the United States of America as the board of directors may from time to time decide. The registered office and place of business of the corporation shall be in the town of Mackay, County of Custer, state of Idaho, and the corporation may maintain offices at such other place or places in said state or United States as the board of directors may from time to time decide. The Post Office address of the registered office shall be Mackay, Idaho."

That at said meeting the adoption of each of the above proposed amendments was duly moved, seconded and unamimously carried; that there was present and voted at said meeting a majority of the total number of members at the regular meeting, as required by the Articles of Incorporation of said cooperative.
