NAME

That the name of this corporation is: LEADERSHIP CALDWELL, INC.

ARTICLE II.

PURPOSES AND POWERS

This corporation is a non-profit organization, and is formed for educational purposes, and especially as follows:

- 1. Said corporation is organized exclusively for educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- 2. To promote a program for the purpose of developing a corps of informed, committed and qualified individuals capable of providing dynamic leadership for Caldwell. The objectives of the program are to:
 - **Identify and motivate potential community leaders to participate in the program.
 - **Give potential and current leaders the opportunity to meet each other, establish a cohesive network, and create a spirit of cooperation for the resolution of future community challenges.
 - **Systematically inform, challenge, otherwise educate the participants of the opportunities and needs of the community, as well as the dynamics of social and economic change.
 - **Give participants the opportunity to gain a working knowledge of the business and political climate.
 - **Provide leadership development and training, and to identify organizational and individual opportunities for community involvement and assist in the placement of participants in these positions.
 - **Provide the opportunity for participants to develop a deeper pride and appreciation of our community.
- 3. To purchase or otherwise acquire and to hold, own and exercise all rights, of ownership in real estate and personal property and to sell, transfer or mortgage said real estate and personal property; to borrow money; to erect buildings or other structures necessary and proper for the carrying out of the purposes herein mentioned; to enter into all contracts necessary in conducting its affairs; to render such aid and assistance to its members as provided by its bylaws; and to receive donations and manage, take and hold real and personal property by gift, grant, devise or bequest.

ARTICLE III.

PLACE OF BUSINESS

That the principal place of business of this corporation shall be at Caldwell, County of Canyon, State of Idaho.

That the address of the initial registered office is 300 Frontage Road, Caldwell, Idaho 83605. The initial registered agent is Kathleen K. Green, President/CEO.

ARTICLE IV.

TERM OF EXISTENCE

That the term for which this corporation is to exist shall be perpetual from and after the date of its incorporation.

ARTICLE V.

CAPITAL STOCK

This corporation does not have and shall not have any capital stock, neither shall it issue to its members, certificates representing capital stock and this corporation shall not be operated for pecuniary profit.

ARTICLE VI.

DIRECTORS

The number of Directors of this corporation shall be fifteen (15), qualifications of Directors and manner of election shall be provided for in the bylaws.
