ARTICLES OF INCORPORATION
OF
IDAHO TRUCK PAC, INC.

KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the provisions of Title 30, Chapter 10, Idaho Code, providing for the incorporation of non-profit associations, and we adopt the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be IDAHO TRUCK PAC, INC.

ARTICLE II

Duration

The duration of this corporation shall be perpetual.

ARTICLE III

Purposes

1. The purposes and objects for which this corporation is formed are: To promote, produce, and foster, on a voluntary, non-partisan and nondiscriminatory basis,

support for candidates for state office within the State of Idaho, who both acknowledge and support the contribution Idaho's Trucking Industry makes to the State's economy.

2. The preceding paragraph shall be construed as objects, purposes, and powers.

ARTICLE IV

1. Membership shall be open to any and all individuals, partnerships, corporations, and associations who qualify according to rules prescribed by the Board of Directors.

ARTICLE V

Powers

1. This corporation shall have all the powers conferred upon non-profit corporations pursuant to Title 30, Chapter 10, Idaho Code.

2. Notwithstanding the foregoing, the corporation shall exercise only such powers as are in furtherance of the purposes and objects set forth in Article III hereof.

ARTICLE VI

No Private Interest in Assets

The corporation is not organized for profit, and no

part of the net earnings of the corporation shall ever inure to the benefit of any private member or individual. In the event of the liquidation or dissolution of the corporation, whether voluntary or involuntary, no member shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property held by the corporation, after the payment of all debts and obligations of the corporation, shall be transferred and conveyed to the Idaho Motor Transport Association.

ARTICLE VII

Registered Office and Agent

1. The address of the initial registered office of the corporation is: 802 West Bannock, Suite 803, Boise, Idaho, 83702.

2. The name of the corporation's initial registered agent at such address is: Greg Panter.

ARTICLE VIII

Directors

1. The number of directors of the corporation shall be fixed by the bylaws except there shall never be less than three (3) directors.

2. The initial Board of Directors shall consist of

three (3) directors, and the names and addresses of the persons who are to serve as the initial directors are as follows:

3. The initial Board of Directors shall serve until the annual meeting of the corporation and until their successors are duly elected and qualified.

4. The qualifications and terms of office of the Directors shall be as set forth by the bylaws.

ARTICLE IX

Incorporators

The initial Board of Directors are also the incorporators of the corporation, and the names and addresses of the incorporators are set forth in paragraph 2 of Article VIII.
