ARTICLES OF INCORPORATION SEP 14 AM 8 27

OF

BUDGET MOTEL OF MONTPELIER, IDAHO, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME:** The name of the corporation is **BUDGET MOTEL OF MONTPELIER, IDAHO, INC.**
2. **DURATION:** The period of its duration is perpetual.
3. **PROFIT:** This is a profit corporation.
4. **PURPOSES:** The purpose or purposes for which the corporation is organized is to acquire, own, operate and manage a motel business commonly known as the Budget Motel in Montpelier, Idaho, and do all things incidental thereto and for the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
5. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is ONE THOUSAND (1000) shares of no par value common stock.
6. **PREEMPTIVE RIGHTS:** Shareholders shall have preemptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
7. **BUSINESS AFFAIRS:** Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the corporation's By-Laws, including restrictions on the transfer of shares.
8. **REGISTERED AGENT AND OFFICE:** The initial registered agent is:


