The initial registered office of the corporation shall be 358 Washington Street, Suite #9, Montpelier, Idaho 83254.

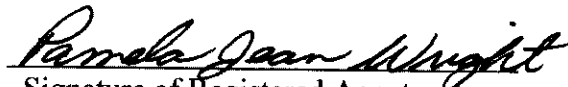
