



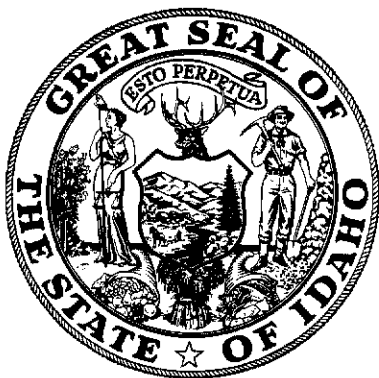
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

BIG ELEPHANT INC.

The undersigned acting as incorporation of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is: BIG ELEPHANT INC.

II.

The Corporation is to have perpetual existence.

III.

The corporation is organized for the purpose of purchasing, leasing, financing, refinancing, and/or selling real and personal property and for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The authorized capital of the corporation consists of a single class of stock, the total number of authorized shares is 250,000 with a par value of \$1.00 and an aggregate par value of \$250,000.00.
