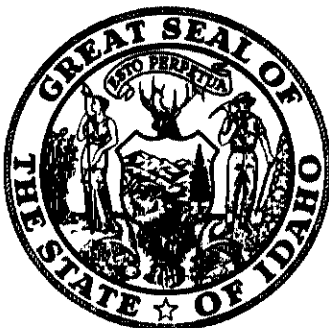
### **CERTIFICATE OF INCORPORATION OF**

The undersigned hereby executes the following Articles of Incorporation for the purpose of forming a corporation under the Idaho Nonprofit Corporation Act (Idaho Code § 30-301 et. seq.).

Article 1: Name

The name of this nonprofit corporation shall be BEDINI BROADCASTING FOUNDATION, INC.

Article 2: Nonprofit Corporation

This corporation is a nonprofit corporation.

Article 3: Corporate Purpose

The purpose of this corporation is to provide a public service through the medium of FM radio broadcast based on a format offering arts and educational programming to the Coeur d'Alene, Idaho geographic area.

Article 4: Duration of Existence

This corporation shall have perpetual existence.
