ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
TWIN SYSTEMS, INC.,

Pursuant to the provisions of the Idaho Business Corporation law, the undersigned corporation adopts the following Articles of Amendment to it's Articles of Incorporation.

ARTICLE I

The name of the corporation is Twin Systems, Inc.

ARTICLE II

The following amendment of the Articles of Incorporation was adopted by the Stockholders of the corporation on the 17th day of May, 1983, in the manner prescribed by Idaho Code Sections 30-1-59, 60 and 61.

Article I of the Articles of Incorporation is hereby deleted and replaced with the following provision;

The name of the corporation is Sooper Ads, Inc.

ARTICLE III

The number of shares of the corporation outstanding at the time of such adoption was 50; and the number of shares entitled to vote thereon was 50.

ARTICLE IV

All outstanding shares were entitled to vote thereon and were common stock.

ARTICLE V
