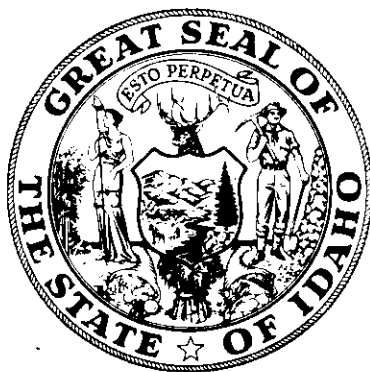

ARTICLES OF INCORPORATION

OF

BLOOMS, BLOSSOMS & BLISTERS NURSERY, INC.

KNOW ALL MEN BY THESE PRESENTS; That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation, under and pursuant to the laws of the State of Idaho, and we do hereby certify:

FIRST: The name of the Corporation shall be BLOOMS, BLOSSOMS & BLISTERS NURSERY, INC.

SECOND: That the Corporation shall have perpetual existence.

THIRD: That the purpose or purposes for which the Corporation is organized are: wholesale and retail plant nursery and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Corporate Act.

FOURTH: That the Corporation is authorized to issue One Thousand (1,000) shares, all of one class, Five Dollars (\$5.00) par value.

FIFTH: That the address of the initial registered office of the Corporation is 211 Shoup Street, Salmon, Idaho, and the name of its initial registered agent at such address is THOMAS M. TAPSCOTT. The Corporation mailing address is as follows: P.O. Box 1052, Salmon, Idaho 83467.

SIXTH: That the number of directors of the Corporation shall be no less than TWO nor more than FIVE, and the names

and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are as follows:
