## ARTICLES OF INCORPORATION OF BUTTE AND SALMON RIVER ELECTRIC RAILROAD COMPANY.

We, the undersigned P. B. Nees, H. W. Rowley, C. A. Arnold, J. J. O'Donnell and C. W. Goddard, citizens and residents of Billings, Montana, do by these presents, pursuant to and in conformity with the provisions of the Civil Code of the State of Montana relating to Corporations and Railroad Corporations, and the Acts of the Legislative Assembly amendatory thereof, associate ourselves together to form a body corporate, and for that purpose do hereby adopt the following articles of incorporation:

First: The name of the corporation shall be  
**BUTTE AND SALMON RIVER ELECTRIC RAILROAD COMPANY;**

Second: The purpose for which it is formed is to construct, maintain and operate a railroad beginning at the City of Butte in the County of Silverbow, State of Montana; thence extending in a general southerly course through the counties of Silverbow and Beaverhead in the State of Montana to or near the mouth of Horse Prairie Creek in said County of Beaverhead; thence in a westerly direction to the Lemhi Pass; thence through said Lemhi Pass and into the State of Idaho, and in a north-westerly direction through Lemhi County, Idaho, to a point on the Salmon River at or near the mouth of North Fork which is to be the terminus; the entire length of said railroad to be about one hundred and eighty-seven (187) miles; - with the right to build such branches thereto as the directors may from time to time determine; and to have and enjoy all other powers, rights and privileges conferred upon railroad companies by the laws of Oregon now existing or that may hereafter be enacted; the amount of the capital stock necessary to construct the said railroad is Two Million Dollars (\$2,000,000.00);

Third: The place where the principal office of said corporation is to be located and its principal office

is Butte, Montana;

Fourth: The term for which the corporation is to exist is twenty (20) years, with the right to renew the same as may be provided by law;

Fifth: The number of the directors of the corporation shall be five (5) and the names and residences of those who are hereby appointed for the first three months of its corporate existence and until their successors are elected and qualified, are as follows: P. S. Moss, H. W. Rowley, M. A. Arnold, T. D. O'Donnell and O. F. Goddard, all residing at Billings, Montana;

Sixth: The amount of the capital stock of the corporation shall be Two Million Dollars (\$2,000,000.00) divided into twenty thousand (20,000) shares of the par value of One Hundred Dollars (\$100.00) each;

Seventh: The amount of the capital stock actually subscribed is Two Hundred Thousand Dollars (\$200,000.00) by the following named incorporators who severally agree to take the number of shares set opposite their respective names:

Eighth: The stock of the company shall not be assessable, nor the private ~~property~~ *Stock* of the stock-holders be liable for the obligations of the corporation;

Ninth: All powers of the corporation shall be vested in the directors who may exercise such powers without the vote or assent of the stockholders, except where otherwise provided by law;
