

ARTICLES OF INCORPORATION

I, the undersigned, natural person of the age of twenty-one (21) years or more, acting as incorporator under the Oregon Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is MILLER AND HENDERSON, GENERAL CONTRACTORS, INC., and its duration shall be perpetual.

ARTICLE II

The initial registered office of the corporation in the State of Oregon is 495 State Street, Salem, Marion County, Oregon 97301; and the initial registered agent for the corporation is Raymond M. Ramsay.

ARTICLE III

The purposes and powers of the corporation are:

- 1. To engage in the general contracting business including commercial, residential and remodeling.
- 2. To engage in any lawful activity for which corporations may be organized under Oregon Revised Statutes Chapter 57.
- 3. To engage in any lawful activity and to do anything in the operation of this corporation or for the accomplishment of any of its purposes, or for the exercise of any power herein set forth which shall appear necessary or beneficial to this corporation in connection therewith.

ARTICLE IV

The amount of total authorized capital of this corporation shall be:

- 1. 150 shares of common stock, no par value.
- 2. No shareholder shall have the preferential or pre-emptive right to subscribe for or purchase any stock of any class, any rights, warrants or options with respect thereto, or any obligation convertible unto or exchangeable for any such stock or other security, whether out of unissued stock or other securities, or out of stock or other securities acquired by the corporation after the issue thereof, regardless of the consideration therefor.
- 3. Each shareholder shall have one vote for each share of record on all matters subsmitted for shareholder approval. No shareholder shall be entitled to cumulate his votes for election of directors.

ARTICLE V

The members of the governing board shall be known as directors, and the number thereof shall be fixed by the bylaws of this corporation. The initial board of directors shall consist of two (2) directors, whose names and residence addresses are as follows:

ARTICLE VI

The corporation shall indemnify, exonerate, reimburse, or defend any present or former director, officer, employe, affiliate, agent or contractor of this corporation for expenses, claims, liabilities, indebtedness, penalties,

damage or injury incurred by or caused by them in such capacity except for their own negligence, knowing unauthorized acts or defalcations not ratified, confirmed or adopted, or the benefit thereof received by this corporation.

ARTICLE VII

The name and post office address of the incorporator signing the Articles of Incorporation is: Robert Craig Miller, 4417 Iberis Northeast, Salem, Oregon 97303.
