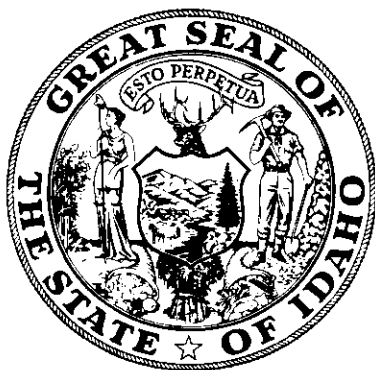

ARTICLE I.

The name of the corporation is ALL AMERICAN BILLIARDS & POOLS, INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.




