KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

I.

The name of the corporation shall be MEDLEY'S HEATING & AIR CONDITIONING, INC.

II.

The nature, objects and purposes for which this corporation is formed shall be:

- a. To engage in the business of selling and installing commercial and residential air conditioning and heating devices, equipment, machinery, and related items.
- b. To acquire, buy, own, hold, sell, exchange, let or lease personal property and real property within the State of Idaho, or outside of the State of Idaho.
- c. To borrow money for the purposes of this corporation, to issue bonds, notes and debentures and other evidences of indebtedness therefore, and to secure the same by mortgage or pledge of personal property, including the income of said corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of the corporation may be pledged, mortgaged or hypothecated.
- d. To build any or all buildings, structures, warehouses or erect the same involved in the said business, building materials, fuel and to acquire the same by purchase, lease or otherwise.

- e. To purchase, lease, or otherwise acquire in whole or in part, the business, good-will, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to be conducted by this corporation, or owning property necessary or suitable for its purpose and to pay for the same in cash, in the stock or bonds of this corporation, or otherwise; to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the conduct of such business.
- f. To enter in any contract, co-operative agreement or profit-sharing plan with its officers or employees that the corporation may deem advantageous or expedient, or otherwise to reward or pay such persons for their services as the directors may see fit.
- g. To purchase, or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer or otherwise dispose of shares of the capital stock of this corporation or evidence of indebtedness of every kind or nature created by any corporation or corporations wherever organized, whether public or private.
- h. To exercise generally the powers generally exercised by business corporations, and particularly the powers provided by the laws of the State of Idaho, in any State of the United States and throughout the World.
- i.
