

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

88 FEB 19 AM 9 11

That pursuant to the provisions of the <u>Idaho Code</u>, Section 30-1-61, TREASURE MAGIC INCORPORATED, an <u>Idaho Corporation</u>, amends its Articles of Incorporation as follows:

- (a) Article IV, Section 1 is hereby amended to increase the total number of common shares of this corporation from 1,000,000 shares to 10,000,000 shares of no par value stock.
- (b) The shareholders adopted this amendment on the 17 day of Jebruane, 1988.
- (c) There are presently 1,000,000 outstanding shares. The number of shares entitled to vote are 1,000,000.
- (d) The vote was unanimously in favor of the amendment.

Except for the change in the authorized number of shares, the original Articles of Incorporation of this corporation and the matters set forth and recited therein are in all respects valid and subsisting and unaffected thereby.
