THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE IDAHO BUSINESS CORPORATION ACT. ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION:
