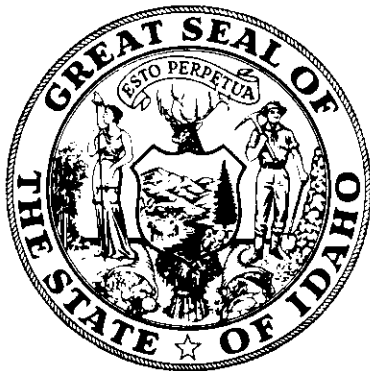

ARTICLE VIII.

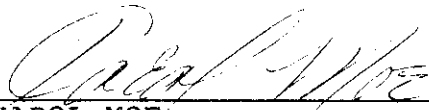

they deem necessary and convenient, providing the same are not out of harmony with the laws of the State of Idaho, or these Articles of Incorporation.

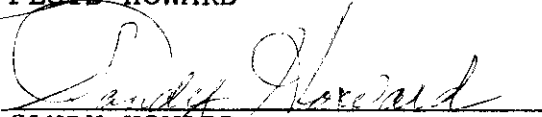
ARTICLE IX.

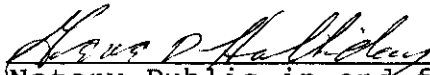
