

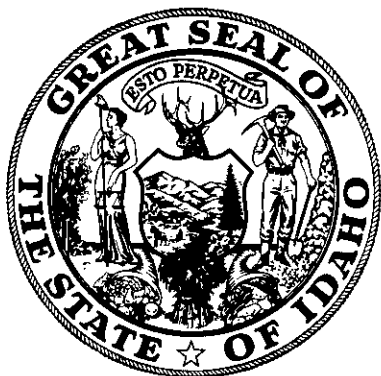
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

TByT, Inc.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

FIRST: The name of the Corporation is TByT, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which this Corporation is organized is for the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is twelve (12), and the par value of each share shall be One Hundred Dollars (\$100.00).
