The undersigned, acting as incorporator of a corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Juliaetta Community Church, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose of purposes for which the corporation is organized is to own and operate a community church in the town of Juliaetta, Idaho, and to perform all acts necessary to the ownership, operation, and maintenance of said church.

FOURTH: Said corporation shall have members, which members shall consist of all persons of eighteen (18) years of age or older whose names are set forth on the official membership list to be maintained by said corporation.

FIFTH: The address of the initial registered office of the corporation is 2304 5th Avenue North, Lewiston, ID 83501, and the name of the initial registered agent at such address is Gregory L. Broemeling.

SIXTH: The number of directors constituting the initial board of directors of the corporation is six and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
