ARTICLÉS OF INCORPORATION of the COEUR D'ALENE STORAGE & PACKING COMPANY

KNOW ALL MEN BY THESE PRESENTS, that We, the undersigned, all of whom are bona fide residents of the State of Idaho, have on this day voluntarily associated ourselves together for the purpose of forming a Corporation under and by virtue of the laws of the State of Idaho, and we do hereby certify as follows:

FIRST: That the name of this Corporation shell be, COEUR D'ALENE STORAGE & PACKING COMPANY

SECOND: That the purposes for which this Corporation is formed shall be:

- (1) To purchase, own, sell, convey, lease, mortgage, hypothecate, or otherwise incumber or contract with reference to real estate.
- (2) To purchase, own, sell, convey, mortgage, incumber, contract with reference to, and to generally deal in personal property.
- (S) To purchase, own, maintain, and conduct a fruit, vegetable and grain storage and packing business and to borrow or loan money and to generally do each and all acts necessary or proper for the purpose of earrying out the object for which this Corporation is formed.
- (4) To purchase, own, sell and convey, contract with reference to crops of fruit, vegetables, grain and other farm products, chattel mortgages, conditional sales contracts, escrows, and equities.

THIRD: That the principal place of business of this Corporation shall be Coeur d'Alene, Kootenni County, Idaho.

FOURTH: The term for which this Corporation is to exist shall be 50 years from and after the date of its incorporation.

FIFTH: That the number of its directors shall be three, a majority of whom must be citizens and actual bone fide residents within the State of Idaho, and the names and addresses of those who are appointed for the first year are as follows:

- C. F. Hess, Coeur d'Alene, Idaho,
- B. J. Klepfer, Coeur d'Alene, Idaho. J. M. Voice, Coeur d'Alene, Idaho.

SIXTH; The amount of the capital stock of this Corporation shall be Twenty-five Thousand Dollars (\$25,000.00) divided into 25,000 shares of the par value of One Dollar (\$1.00) each.

SEVENTH: The amount of capital stock actually subscribed and the names and addresses of the persons by whom such capital stock in actually subscribed are:
