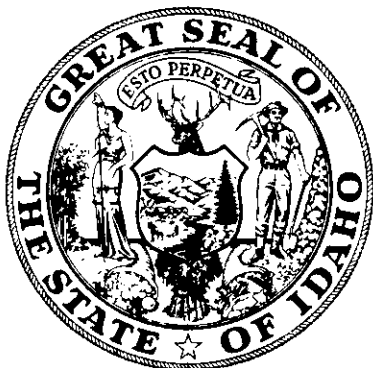

Pursuant to §30-325, 326, and 327 Idaho Code, be it remembered hereby that on October 16, 1985, the Board of Directors of Horizons Development Center, Inc., an Idaho non-profit corporation, did unanimously approve the ammendment of the Corporation's Articles of Incorporation, by adding a new Article IX thereto, as follows:

Article IX.

(a) This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.


(b) Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code.


(c) Upon the winding up and the dissolution of this corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

In all other respects the existing articles of Incorporation were confirmed.

There were, on the date of such meeting, no members of the Corporation.


